Every mineral and placer permit application in British Columbia, captured every morning before the province overwrites it. This pack shows what that record can tell a vendor working out of the South Central, and what it cannot.

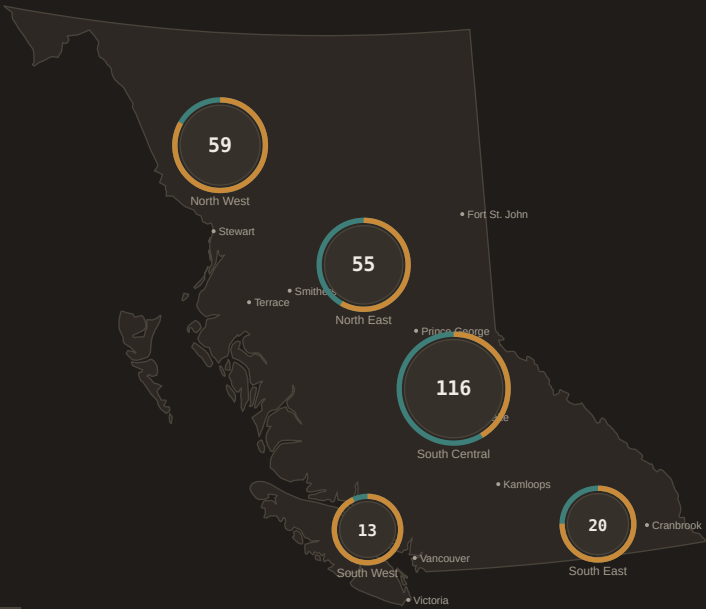

Arrows mark a change in yearly pace of 15% or more against the decade before. Records before 1990 are sparse and not shown. Only filings after the start date have a history; everything before it is a single snapshot.



The government is solving the permit delays. BCMI is solving the blindness.

The feed overwrites itself. Yesterday exists only if someone kept it.

WHY THE PUBLIC RECORD HAS NO MEMORY

BC's Notice of Work feed is public and free. It shows every mineral and placer permit application in the province, with its status today. What it does not show is what the status was last Tuesday. Each morning the feed replaces itself, and the previous state is gone.

WHAT DAILY CAPTURE GIVES YOU

BCMI captures the feed every day and keeps every version. The result is a record nobody else holds: when each application appeared, when it moved from received to referred to approved, when it stalled, and when it was withdrawn. Seen daily, the record becomes something you can plan against: when programs get their permit, when they mobilize, and how long the queue actually runs.



WHAT A FILING TELLS YOU

- That a program exists, and which region it is in
- What it proposes: drilling, a camp, access, and how many hectares
- What stage the application has reached
- Since capture began, the day it moved

What is deliberately not in it

- **Contractor identity.** Almost never in the public record.
- **Operator as a series.** The permittee field is populated on about six rows in ten and contradicts itself.
- **Commodity.** The field is blank far more often than not, and too coarse to rely on when present.

What is in the store

Coverage	Every Notice of Work in British Columbia, all five regions, all permit types: 41,306 applications, submission dates from the 1970s to today.
Capture	Daily, province-wide, since 11 August 2026: captured on 35 of 36 days. Golden Triangle cohort since 30 June 2026: captured on 77 of 78 days. Checked daily for gaps; the live site always shows its most recent capture date, and flags it plainly if that capture falls behind.
Change log	Every field change between captures, by day, from 12 August 2026: status moves, new filings, work-start and work-stop notices.
Counted by BCMI	Figures BCMI computes from the record rather than reads from it, marked counted by BCMI wherever they appear. Defined on page 7.
Source	BC's Notice of Work registry (mines.nrs.gov.bc.ca), via the Province's OpenMaps geospatial service. Contains information licensed under the Open Government Licence – British Columbia.

- **Helicopter, assay, environmental and fuel demand.** No field exists.
- **Ownership, finances, any rating or lead score.** Not in the record, and BCMI does not add them.

BCMI captures the government's application record, never the commercial activity between vendors and operators.

Regional blind spots mean missed opportunities.

YOUR REGION

Your surrounding regions now reveal permit activity. Find yours in Table 3.1; the other four rows are the work you are not watching.

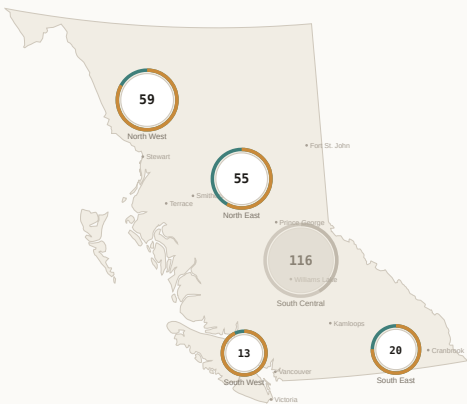
Live mineral and placer filings by mine region, twelve months to the capture date. Live means filed and either still in the queue or approved; withdrawn, rejected and on-hold files are excluded.

A Kamloops operator focused on the South Central is missing **147** live filings in the other four regions, **60** of them declaring drilling.

Mineral is hard-rock exploration and mining: drilling, trenching, camps, helicopters. Its volume sits in the northern and interior regions, and on mineral alone the North West, North East and South Central are level.

Drilling, camp and access are filings declaring a proposed area above zero for that activity: what the applicant proposed, not what was built. **Declared area** is the hectares those filings put on paper; most amendments to an existing footprint declare none. **Working** is mines whose work-start notice is dated within the last twelve months, on or before the capture date, with no stop date passed. A missing notice means nothing; 39% of live mines have one.

Placer is gold recovered from gravels with excavators and wash plants, mostly small and seasonal. It almost never declares drilling but camps and fuels at a similar rate. It is concentrated in the Cariboo: **68 of South Central's 116** live filings are placer.

Reading one row, the South Central. 116 filings are live: 63 already approved (quote now), 53 still queued (quote later). Of the 116, 23 propose drilling, 9 a camp and 29 access work; a filing can declare more than one. They sit across 103 mines, 9 of which have told the regulator a season is under way. The row is a funnel: how many exist, how many are cleared, what each will need, how many are already moving. Filings and mines are different counts, so the approved column will not match the mine counts on page 4, where your shaded row is lifted out.

What moved in the South Central.

What you can do about it

- Rule-generated from the change log for the fortnight to the capture date. The names are a sample of the named version; every subscriber gets this for their region.
- ☐ **CALL THIS WEEK** 2 filings approved in the last 14 days: **Red gold, Woodjam South**. A program that just got its permit is buying now.
- ☐ **MOBILIZING** 5 work-start notices for the next fortnight or just past: **Rabbit North (Sep 12), Copperview (Oct 15), Copper Keg (Sep 19), Quesnel Project - Central N (Sep 7)** and 1 more. Camp, fuel and crews move first.
- ☐ **PARKED** 4 moved to Client Delayed (**Blue (Blueli), Dot, Alwin Copper Mine** and 1 more): stop chasing, check back in a month. 1 came off hold (**Hedge Hog**): back in play.
- ☐ **EARLY SIGNAL** No new filing declaring drilling or a camp appeared in the last 14 days.
- ☐ **THE QUEUE** 53 filings waiting on a decision; **41** projects filed more than 90 days ago. Ask about those, not the fresh ones.
- ☐ **YOUR TURN** Share your region and what you quote on at inquiries@bcminingintel.com, and say what would make this read useful on a Monday.

Table 3.1 shows what is permitted. This table shows what is actually moving, because a permit and a mobilized crew are two different things. It counts mines, not filings.

48 mines are approved and not yet started, **4** of them declaring drilling and **1** a camp: allowed to work, nobody necessarily hired. Your best calls this week. **8** are already under way and likely staffed. **47** are still in the queue, too early to call. 1 mine works under an earlier permit while the latest filing waits: working in Table 3.1, not yet permitted here.

If you quote on any of these, this page is about you

- Camp declared** Camp services, catering, water and waste, fuel and power.
- Drilling declared** Drilling contractors, core handling, assay, helicopter support.
- Access declared** Road building, aggregate, culverts, freight.
- Placer operation** Excavation, wash plant and water management, fuel and heavy equipment. Read from the permitted area alone; BC's filing does not break placer work into types.
- Work start** Everything that moves in the first week: freight, fuel, camp, crews. Median notice before the start date: about 11 days.

Our reading, not the record. A declared area says what was proposed, not who was hired.

The five mines in the South Central that moved most recently.

THIS PAGE A sample of the paid view: the mine, its latest filing, where it stands, and the last thing that happened to it.

Orange rows are permitted and not yet started: quote now. This is what every row of the named version carries, for every live mine in your region, every Monday. Nothing on it is an opinion about a mine: no ownership, no finances, no rating. Those are not in the record and BCMI does not add them. Chosen by rule, not by hand: the live mines with the most recent event in the change log, at most five.

Three clocks to plan against

The record does not forecast. It does show, consistently, how much warning each kind of event gives. Plan around that.

Approval

Arrives with no warning in the public feed. The day a program is permitted is the day it can buy. In the last fortnight the region logged 2 approvals.

Work start

Notices have arrived a median of 11 days before the start (22 notices to the capture date, 17 of them filed in advance, adjusted for the day between BC's stamp and BCMI's morning capture). Too short for a drill contract; right for camp, fuel, freight and helicopter.

On hold

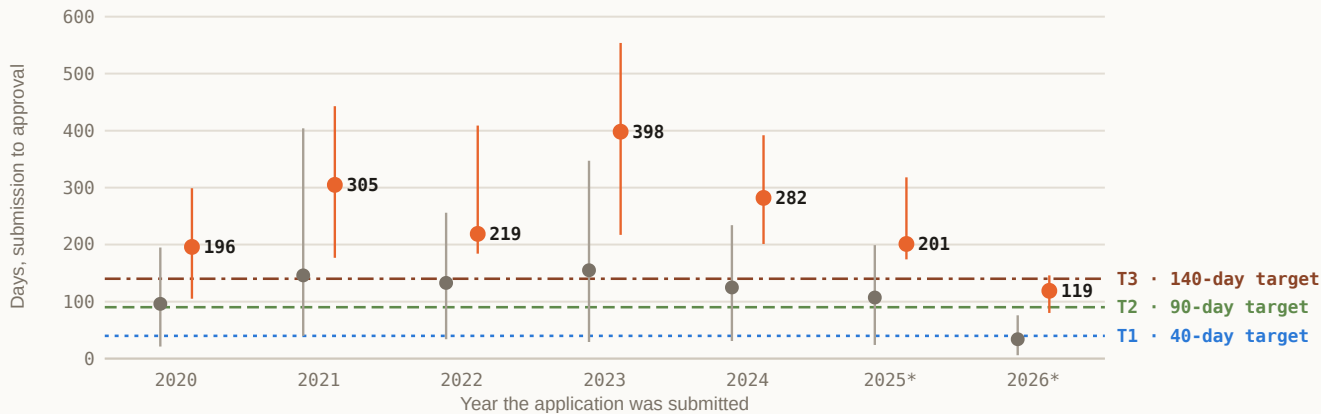
A file marked Client Delayed is paused at the applicant's request and the government's clock stops. Among new mineral filings since April, the median wait in that state is 147 days (10 files). Stop chasing; check back monthly.

How long approvals take, against the 40 / 90 / 140 day targets.

SINCE 1
APRIL 2026

BC's tiered targets took effect 1 April 2026. This is where actual approval times sit against them, by year, and what has happened to filings made since.

FIGURE 6.1 · Days from submission to approval, mineral, by year submitted counted by BCMI



Each point is the middle filing for that year: half faster, half slower; the bar covers the middle half. Orange is new permits, grey amendments. Years marked * are still open, so those medians read low. BCMI counts calendar days from submission; BC's clock starts at acceptance and pauses while the file sits with the applicant, so BCMI's number always reads higher. Neither is wrong.

In the fastest complete year since 2020, the middle new mineral permit still took **196 days** from submission; the slowest year was **398**. BC's longest target is 140. Yearly medians, 2020 to 2024: 196, 305, 219, 398 and 282. Amendments filed since April approve in a median of **13 days**; this season's programs are amendments to permits that already exist.

34 filings. The most common state is Client Delayed, the state the government's clock does not count. Both tables are true; a vendor plans in calendar days, so plan from this one.

Ministry page, 1 April to 31 August 2026, as published on 15 September 2026. Their clock starts at acceptance and pauses while a file is with the proponent, so it always reads lower than calendar days.

A change log for the people who quote the work.

Who this is for, the definitions behind every number, and how to reach BCMI.

Camp, fuel, freight, helicopter and expediting

A Monday read for your region: which programs were approved, which filed a work start, which went on hold, which appeared. Then the full list of live mines in your region with a quote-window state on every row. Thirty seconds on a Monday.

The analyst

The province's permitting record as a time series: when filings arrive and when decisions land, how long approvals take by year against the targets, how deep the queue is in each region and how often files stall. Numbers nobody publishes. Anyone republishing a figure gets the query behind it.

Definitions used in this pack

Live filing	Status Received, Referred, Referral Complete or Approved; submitted within twelve months of the capture date. Client Delayed is excluded from live and shown separately as on hold.
Queue	Live and not yet Approved.
Working now	Mine's work-start notice within the last twelve months, on or before the capture date, no stop date passed. Older notices are treated as stale.
Approval days	Approval date minus submission date, calendar days, using the amendment issue date only where it is on or after submission. The government's clock is different and shorter by construction.
Capture date	The morning the record was last captured, printed on the cover as the end date and in every footer. Every window in this pack ends there, never at today's date, so a stalled capture cannot quietly shrink a window.
Counted by BCMI	A figure BCMI computed from the record rather than read from a field in it: days in stage, approval durations, declared activity by type, quote windows. Marked counted by BCMI wherever it appears. Every figure is checked against its source on the day the pack is built, and if a check fails the pack does not build.
